**STEPHEN C. BEHRENDT** is George Holmes Distinguished University Professor of English at the University of Nebraska. A scholar in British Romantic literature and culture as well as a widely published poet, he is also author of *Royal Mourning and Regency Culture: Elegies and Memorials of Princess Charlotte* (Macmillan, 1997).

**TODD F. DAVIS** teaches American literature and creative writing at Penn State Altoona. His scholarship has appeared in such journals as *Studies in Short Fiction*, *Style*, *College Literature*, *Interdisciplinary Literary Studies*, *Critique*, *Literature/Film Quarterly*, *Midwest Quarterly*, and *Western American Literature*. He is co-author (with Kenneth Womack) of *Formalist Criticism and Reader-Response Theory* (Palgrave/St. Martin's) and co-editor (with Womack) of *Mapping the Ethical Turn: A Reader in Ethics, Culture and Literary Theory* (UP of Virginia). In addition Davis is the author of a book of poetry, *Ripe*, and his poems have appeared widely in such magazines and journals as *The North American Review*, *River Styx*, *Green Mountains Review*, *The Nebraska Review*, *Many Mountains Moving*, *The Worcester Review*, *The Red Cedar Review*, *The Midwest Quarterly*, *Yankee*, *Appalachia*, and *Image: A Journal of the Arts & Religion*.

**LISA DICKSON** is an Assistant Professor in the English Program at the University of Northern British Columbia. She has published articles in such journals as *Renaissance Drama*, *Camera Obscura*, and *Canadian Literature* and is currently working on a book-length study of the representation of violence and penal practice in modern productions of Shakespeare's dramas.

**HEATHER DUBROW**, Tighe-Evans Professor and John Bascom Professor at the University of Wisconsin-Madison, is the author of five scholarly books, most recently *Shakespeare and Domestic Loss: Forms of Deprivation, Mourning, and Recuperation* (Cambridge UP, 1999); her other publications include articles on pedagogy, two chapbooks of poetry, and a forthcoming edition of *As You Like It* for the New Riverside Shakespeare.
