**Mark Baker** holds a B.A. (Special) in History. His area of specialization is Eastern European history, with particular attention to the Ukraine. He is currently writing his M.A. thesis which deals with British historians' perspectives on Eastern European history and the impact these perspectives had on the West's understanding of Eastern Europe. He holds a Province of Alberta Graduate Scholarship.

**Serge Cipko** is a Ph.D. candidate in the Department of History at the University of Alberta and the author of several scholarly articles, mainly in the field of Ukrainian history. He has taught at MacQuarie University (Ukrainian history and civilization) and the University of Alberta (history of Ukrainians in Canada) and will be lecturing as of September 1992 at Concordia College in Edmonton in world history and European history. The topic of his thesis is the history of Ukrainian immigration into Argentina between 1919 and 1939.

**Robin Close** is currently pursuing a Masters degree in History at the University of Alberta. Her thesis project, supervised by Philip Lawson, concerns British policy towards Quebec following the Quebec Act of 1774.

**Chris Hackett** is a Ph.D. Candidate at the University of Alberta. He has received several fellowships and was awarded the James H. Gray Medal and the Margaret McWilliams Medal for work on his M.A. thesis at the University of Manitoba. He has published *A Bibliography of Local History in Manitoba, Second Edition* as well as an article in *The Anglican Church and the World of Western Canada, 1820-1970* edited by Barry Ferguson. At present he is studying the relationship between the Anglo-Protestant Churches of Western Canada and the development of the social and political culture of the region in the period between 1870 and 1914.

**Bob Hesketh** completed his M.A. in history in 1989 at the University of Alberta where he is now a Ph.D. candidate. His doctoral thesis re-examines the influence of Major Douglas's theories on Alberta Social Credit from 1932 to the 1960s. He has published in *Prairie Forum* and is currently the holder of an Isaak Walton Killam Memorial Scholarship. At the University of Alberta, he has taught post-confederation Canadian history and, as of September 1992, will be teaching post-1945 Canadian history.

**K. Tony Hollihan** has a B.A. (Honors) from Memorial University and a B.Ed. and M.A. in history from the University of Alberta. He is presently a Ph.D. candidate in Educational Foundations at the University of Alberta. He has taught in the Edmonton Public and Catholic school systems and at the University of Alberta (education in Canada). His one previous publication, in the *Canadian Encyclopedia* (2nd ed.), is entitled "Henry David Wilton." His thesis topic is teacher education in Alberta, as it evolved from a normal school environment to the Faculty of Education.

**Bob Irwin** earned his M.A. at the University of Saskatchewan in 1988 for his thesis on the Saskatchewan Co-operative Elevator Company, 1911 - 1917. He is now a Ph.D. candidate in history at the University of Alberta where he has also lectured on the Canadian West since 1870.
